Applications are invited from the eligible candidates in the prescribed format for preparation of a panel list for engagement as Staff Nurse on contractual basis in M.K.C.G. Medical College Hospital, Berhampur against existing vacancies and vacancies likely to be occur in the service with in the year 2016 as detailed below.

Reservation:-

The reservation of vacancies in respect of S.C, S.T, SEBC, Physical Handicapped, Ex-serviceman & Women candidates shall be applicable as per Govt. Rules.

AGE LIMIT:-

The Candidates must have attained the age of 21 years and must not be above the age of 32 years on the date of advertisement. The upper age limit is however relaxed by 5 years in respect of ST/SC/Women candidates and 10 years in case of physically handicapped candidates and in case of Ex-serviceman candidates as per prevailing rules. A person who comes under more than one reserved category, shall be eligible for only one benefit of relaxation, which shall be considered most beneficial to her/him.

Provided further that, the Staff Nurses engaged on contractual basis under the Central Plan Schemes, State Plan Schemes and externally aided Schemes against the post created with the concurrence of the Finance Department, who are below the age of 45 years and have completed at least one year of continuous service as on the date of advertisement can apply for the post through their respective authorities.

Provided further that the ASHA Karmies working in the health system of the State who are below the age of 45 years and have completed at least one year of continuous services on the date of advertisement can apply for the post if they are having the minimum prescribed qualification.

SCALE OF PAY & NATURE OF ENGAGEMENT :-

I. The appointment to the posts shall be made initially on contractual basis on consolidated monthly remuneration of Rs. 8000/- (Pay-Rs. 5200/- + GP Rs. 2800/-) in Pay Band -I Rs. 5200-20200/- & GP Rs. 2800/-

II. The condition of service and the tenure of the contractual appointment to the posts will be regulated by the Odisha Group "C" & Group "D" posts (Contractual appointment) Rule-2013

MODE OF SELECTION :-

1. The selection of candidates shall be made on career assessment as detailed below:

Provided further that, the Staff Nurses engaged on contractual basis under the Central Plan Schemes, State Plan Schemes and externally aided Schemes against the post(s) created with the concurrence of Finance Department or engagement made through manpower service provider agencies with concurrence of Finance Department who are below the age of 45 years and have completed at least one year of continuous service on the date of advertisement shall be allowed one percent extra mark of the total marks for each completed year of continuous service subject to maximum of fifteen percent which will be added to the marks secured by them for deciding merit position.

GENERAL CONDITIONS :-

1. Be a Citizen of India.

5. Have not more than one spouse living, if married.
 6. The candidates must have registered their name in Odisha Nurses & Midwives Council & have processed valid registration certificates as on the date of advertisement.
 7. Appointment is purely on contract basis and may be terminated any time without assigning any reason thereof.
 8. The selected candidates will have to undertake that they will not claim any financial benefits other than the monthly remuneration of Rs. 8000/- which they will receive.
 9. Preference will be given to the candidates belong to permanent native of the Ganjam District and in case of vacancies not filled-up, applicants belonging to other district of the State will be considered.
 10. Candidates appointed on contractual basis will not claim for inter Medical College/District transfer.
 11. In-Service contractual Staff Nurses/ ASHA Karmies should submit their service certificate issued by the competent authority.
 12. The envelope containing the application should be superscribed as application for the post of contractual Staff Nurse.
 13. The applications should reach in the office of the undersigned within 30 days from the date of publication of the advertisement in news papers by Regd. Post/Speed Post only(application received by any other mode will be not be entertained).
 14. Incomplete application(s) or application(s) received after due date shall be rejected. Authority shall not be held responsible for postal delay.
 15. The undersigned reserve the right to modify/ cancel the advertisement or postpone the recruitment procedure without any reason thereof.

 17. No personal query will be entertained in the recruitment / selection process.
 18. Canvassing in any form will be a disqualification.

Knowledge in Odia:

The candidates must

- a) be able to read, write and speak Odia.
- b) have passed middle school examination with Odia as language subject or
- c) have passed matriculation or equivalent examination with Odia as medium of examination in non-language subject; or
- d) have passed in Odia as language subject in final examination of class-VII from a school or educational institution recognized by the Government of Odisha or the central Government; or
- e) have passed a test in Odia in Middle English School standard conducted by the School and Mass Education Department.

If any candidate is found to have suppressed any material, information or furnished false information/documents, her/his case shall not be considered for the post applied for and in case already engaged on the basis of the said information/documents, her/his service shall be terminated forthwith. Candidates who have been disengaged previously on administrative ground such as disobedience/poor performance/misbehavior/criminal activity etc. are not eligible to apply.
