5. One passport size photograph duly attested by a gazetted officer to be affixed in the application form for the space provided.

7. Experience Certificate from the appointing authority, if applicable.

Recruitment Procedure:

Recruitment of the post of paramedics (Jr. LT, Jr. Radiographer, Pharmacist & Attendant shall be made by way of career assessment.

ELIGIBILITY CRITERIA:-

i). Nationality – She / he must be a citizen of India

ii) Age limit – A candidate must have attained the age of 18 years and must not be above the age of 32 years for Attendant & 21 to 32 years for other posts. *as of dt. 21-12-2016.*

Provided that the upper age limit in respect of the entire reserved category will be relaxed as per the rule, Act, order or instructions of the Govt.

Paramedics engaged on contractual basis under central plan scheme/ state plan scheme and externally aided scheme will be consider for the age of 45 years.

EDUCATIONAL QUALIFICATION:-

Jr.Laboratory Technician

Must have passed +2 Sc. Examination under CHSE, Odisha/ equivalent & passed Diploma in Medical Laboratory Technology from any of the three Govt. medical college & hospital of the state/ any other private institution recognized by Govt. of Odisha or AICTE.

JUNIOR RADIOGRAPHER

Must have passed +2 Sc. Examination under CHSE, Odisha/ equivalent & passed Diploma in Medical Radiation Technology from any of the three Govt. medical college & hospital of the state/ any other private institution recognized by Govt. of Odisha or AICTE.

PHARMACIST

Must have passed +2 Sc. Examination under CHSE, Odisha/ equivalent & Diploma in Pharmacy from any of the three Govt. medical college & hospital of the state/ any other private institution duly recognized by Pharmacy Council of India/ AICTE.

ATTENDANT

Must have passed M.E. (07th Examination) or equivalent and can read write and speak odia. The 7th pass certificate must be verified by Block Education Officer & then be countersigned by the concerned District Education Officer only applicable for the selected candidates.

SELECTION PROCEDURE:-

The selection of all the paramedics will be done on merit basis based on the career assessment.

Provided that contractual paramedics working in Central Plan Scheme / State Plan Scheme / Externally Aided Scheme who have recruited in due procedure shall be allowed one percent extra mark i.e. one mark for each complete year as the total mark is 100 (one hundred) for each complete year of continuous service to a maximum of fifteen percent to the mark secured while deciding the merit list.
