**RESERVATION:**

Reservation for PH, Sports Man, Ex-Service Man, SC, ST and SEBC are applicable under concerned rules.

**Eligibility criteria:**

He/She must be a citizen of India..

**AGE:**

The candidates must have attained the age of 21 years and must not be above the age of 32 years on the date of advertisement. The upper age limit in respect of the reserved categories of candidates referred to in rule 5 shall be relaxed in accordance with provisions of the Act, rules, orders or instructions for the time being in force, for their respective categories. Further who has engaged on contractual basis under the Central Plan Scheme, State Plan Schemes and externally aided Schemes who are below the age of 45 years and have completed at least one year of continuous service shall be allowed to take part in recruitment process as specified in rule 10 of these rules.

**Knowledge in Odia:**

The candidate must be able to read, write and speak Odia and passed middle school examination.

**Marital status:** The candidate must not have more than one spouse living if married.

**Physical Fitness:**

The candidate must be of good mental and physical health and free from any physical defects likely to make him incapable of discharging her/his normal duties in the Service. A candidate who after such medical examination as the Govt. may prescribe is not found to satisfy these requirements as specified above shall not be appointed to the service. He must have registered his name in Pharmacist Council in the State and have possessed valid registration certificates as on the date of the advertisement.
